The purpose for which the corporation is organized is to establish and maintain a Unitarian Universalist Church in Lee County, Florida. The purpose for which the Church is being founded is to advocate diversity, be committed to liberal spiritual development, work to achieve social justice for the oppressed, and exhibit loving care and informed concern both for our members and for the larger communities of which we are a part.

ARTICLE IV, MANNER OF ELECTION

The manner in which the directors are elected or appointed: In the founding year of 2001, Directors were elected by Founding Members by nomination and election at its monthly meeting on May 19, 2001 to serve until March 2002. Beginning in March 2002, and every two years thereafter, all Directors are to be elected from a slate of candidates chosen by a Nominating Committee of five(5) members of the Congregation. The number of Directors may be increased or decreased in accordance with the Bylaws but shall never be less than three(3).
