

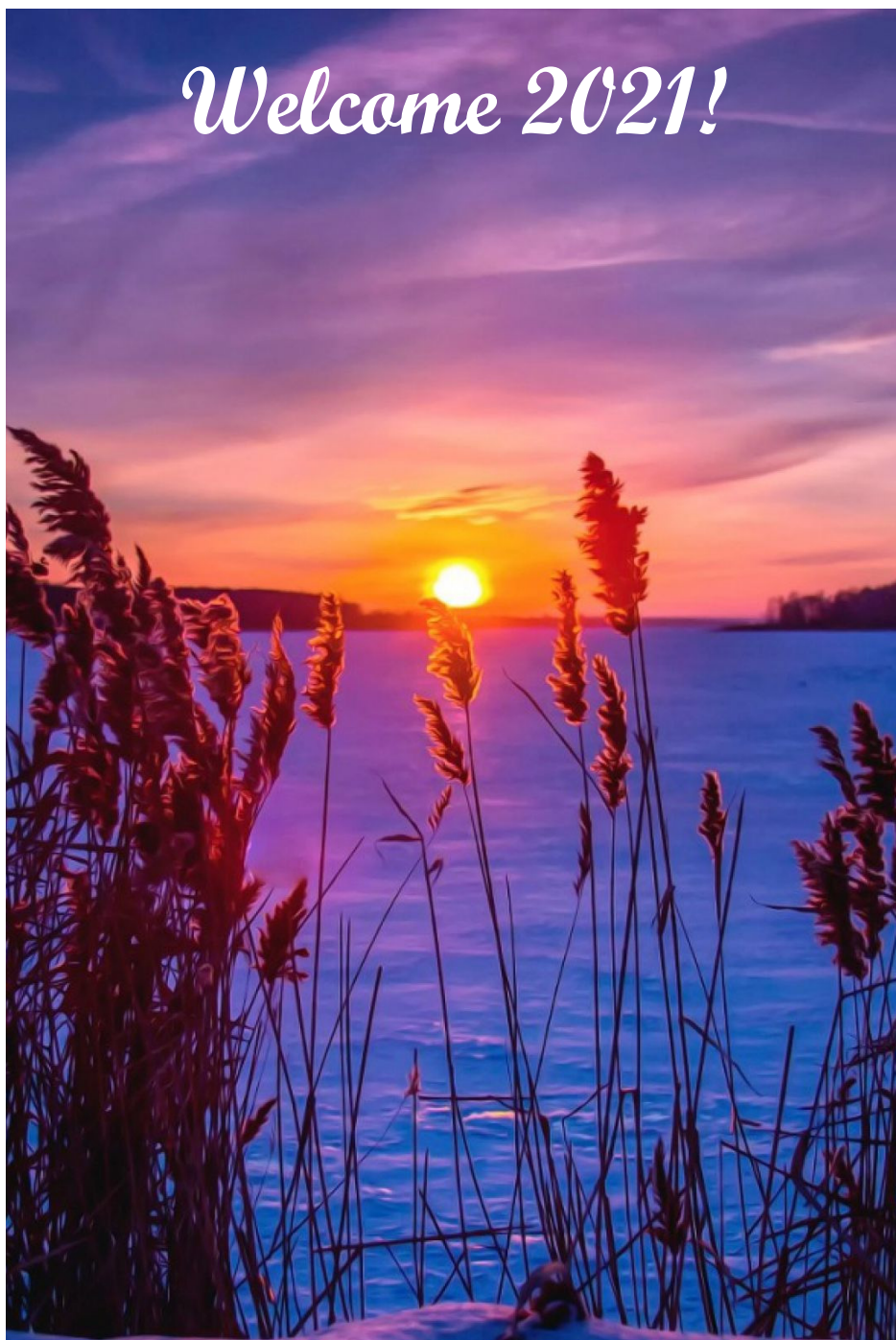

The December 16, 2020 Board of Directors meeting was held at 1:00 p.m. via Zoom with all members present.

We continue to have many topics/issues to discuss as we strive to keep everything moving in a positive direction. We look forward to 2021 bringing lots of changes and a return to more “normal” times.

Building and grounds was the subject of several discussions. John Conrad presented the concept of performing a reserve study to better quantify when major repairs and replacements will be needed and to develop a schedule for the amount needed annually to meet these large ticket expenses. The Board agreed that this is a good idea but our budget can’t afford the cost at this time. We will reassess our ability to do the study later in 2021. In 2015 an All Faiths Building and Grounds Immediate and Long Range Plan was developed that identified a schedule

for many actions needed in facilities maintenance. Most of the actions identified have been performed. However, this plan needs to be updated. Peter Erickson will be the board member leading a team making the updated revision. Existing members of the Building and Grounds Committee are being asked to contribute. The Building and Grounds Committee needs additional members to replace members who have left during the past couple years.

During the past eight months, COVID-19 has eliminated our fundraisers, thus hurting our income. The Board discussed potential options for conducting fundraisers while maintaining social distancing. These included an on-line auction and a livestreamed concert by our talented musicians.

The Bylaws Committee is being requested to meet to review changes that may be needed for presentation at the next annual meeting. Mem-

bership on this and other committees is being reviewed and revised/expanded as needed. If you are willing to serve on one of our committees, please let me know.

The Stewardship Committee is making good progress towards the pledge drive that will start in January. The drive will have some surprises this year. With several traditional sources of income being reduced because of COVID-19 the success of this pledge drive in replacing lost income is extremely important. We do not want to be forced into further budget cutting.

The purchase of cameras, cables, and controls for recording/streaming services is moving forward and should be installed in January. The need for this equipment was put on the Wish List last month; we received some contributions but could use more.

The farmer’s market that will set up in our grassy area

(mentioned in the last *Connections*) will be starting once they get all their permits. They plan to operate Tuesday through Friday of each week.

If the new COVID-19 relief legislation being negotiated includes a new forgivable Paycheck Protection Program (PPP) loan, the Board voted to apply again. If it is considered a potentially forgivable loan like the last one, we will conduct an email vote to obtain the Congregation’s approval as we did before applying the last time it was offered. The last PPP loan meant we didn’t have to cut staff salaries.

The Finance Committee reports that the pledge and cash contributions for November and early December is significantly below last year. Normally we see a large increase in collections during these months but have not seen it yet.

Enjoy these holidays and the loving spirit of Christmas.

FROM MCGREGOR BOULEVARD

Many of us are feeling hopeful with the approval and distribution of a vaccine. I've heard many around the world say that they feel liberated and they are letting their guard down in terms of breaking their many months of isolation. This is likely dangerous. We know so much more now about COVID-19 and its transmission than we did last spring. Still, we need to be cautious and listen to the doctors and scientists. And so, I have.

I've listened to you too. Living in isolation and not being able to gather as a congregation has drained your reserves of patience, attacked your emotional health, and has broken your hearts. For months now your Board of Directors, your Sunday Services Committee, your staff, and your Minister have recognized the needs of the congregation, but couldn't make any changes in how we have been forced not to gather as your safety is incredibly important.

By listening to doctors, scientists, and the CDC we have been able to reach a decision that will allow us to gather. Well, gather a little at one time. We feel it's safe to make some

slow and small changes given we work within some safe and reasonable parameters.

Beginning on February 7, 2021, we will open our 10:30 a.m. Sunday services to 20 members and known friends of the congregation. The public is not invited at this time. We will livestream with 20 people in the seats. The gathering will be like your first school dance. There will be no huggy wugsy, kissy wissy, handshakes or singing. Chaperones will remind you to leave room between you and the other person.

■ If you'd like to be one of the 20 people attending the service on a Sunday, you will need to register with Regina Kilmartin in the office. You will receive an RSVP email prior to the service, and Regina will fairly schedule people.

■ If you have serious medical conditions or identify as high risk we encourage you to stay home.

■ If you are feeling ill or have recently been ill, please stay home.

■ You will be screened upon arrival, you must wear a mask properly, and remain socially distanced.

■ Seating will be arranged prior to your arrival.

■ To avoid contact, people will enter and exit as directed by staff. We need to avoid people "bottlenecking" and gathering. Those in attendance must remain socially distanced from our staff and service volunteers.

■ Please arrive at least 15

minutes early so you can be seated by 10:30 am when the service goes live.

■ Microphones will not be shared. Joys and Sorrows will be presented by the minister.

■ We will continue to use overhead fans and open windows for ventilation. Be prepared for a tiny bit of traffic noise.

■ Proper cleaning procedures will continue.

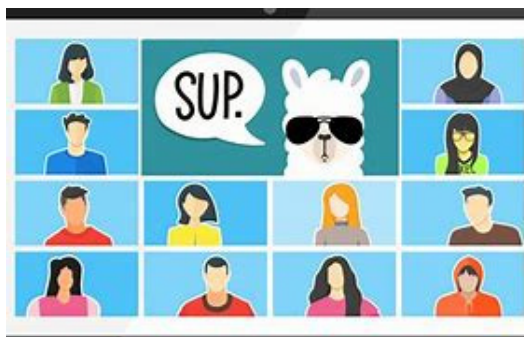

CLIMATE ACTION TEAM NEWS

Your Climate Action Team is gearing up to meet the challenges of the new year with renewed determination and commitment. We are encouraged by the impressive team President-Elect Biden is assembling to address the challenges of climate change at the federal level. However, our Florida State government remains in the hands of those whose overriding priority is economic development. This is also true of many in our local governments. Last month, CAT began what will be an ongoing campaign to reach out to our elected officials with our intensifying concerns about the impact of climate change on our well-being both now and into the future. Our campaign began with this congratulatory letter from the All Faiths Climate Action Team to each of the recent election winners in Lee County local, state and federal elections:

"Congratulations on your win in the November election. Our sincere thanks to you for having the courage and commitment it will take to serve the public interest in such a difficult and uncertain time.

"Recovering from the damage caused by the COVID-19 pandemic will be challenging and will no doubt require considerable bi-partisan effort and painful trade-offs. Hopefully we can learn from this essential and unavoidable effort lessons that will prepare us to deal with the much greater threats we face from the ever-increasing impact of climate change. We are running out of time to be able to make a difference. What we do (or fail to do) today will determine the tomorrows we leave for our children.

"We are counting on you to find ways to help unite your fellow elected officials in the true spirit of public service and representative democracy so that, together, we are strong and ready to meet the enormous challenges that lie ahead."

Lee Interfaith for Empowerment

Several All Faiths' Lee Interfaith for Empowerment (LIFE) network members have participated in Zoom meetings held in the past few weeks.

The Affordable Housing Action Team (AHAT) met with Michael Anderson, the director of the Center for Community Change's Housing Trust Fund Project. Mr. Anderson will speak at a late February meeting LIFE is planning with Fort Myers officials. AHAT also interviewed two local developers interested in building affordable housing. They brought to light the criticality of incentivizing the erection of affordable housing. Upcoming AHAT Zoom meetings:

■ **January 12, 1:00 to 3:00 pm, interview the head of the Community Redevelopment Agency, Michelle Hilton Terry;**

■ **Team meeting on January 26 at 5:00 pm**

The Criminal Justice Action Team (CJAT) met with Linda Doggett, Lee County Clerk of Courts; they learned that the \$12 million collected annually in fines and fees are used to fund the Clerk of Courts' budget. A meeting with Vacharee Howard, Executive Director of the National Alliance on Mental Illness (NAMI), revealed that there are only 140 mental health beds in Lee County. CJAT also met with a statewide criminal justice collaborative that is working to expand the use of adult civil citations in lieu of arrests for minor offenses. At a meeting with Kathleen Smith, head of the Lee County Public Defenders Office, CJAT was encouraged by her mutual interest in reforming the fees/fine imposed on offenders and encouraging Lee County law enforcement departments to use adult civil citations. Revenue/Operating Income **decreased** significantly in November, compared to October. Recently, congregants received a notice as to where their actual pledge contributions are compared to their pledge itself (from April 1 through November 30). It is our hope that the last 4 months of the fiscal year see a significant **increase** in giving so that our goal budget is achieved. These are critical and difficult times for all of us; your generosity is appreciated!

The Burn the Mortgage program continues with donations of \$600.00 received in November (these funds will be used to pay down the mortgage principal in December). The outstanding mortgage principal at the end of November was \$95,266.64. This is significant progress because on April 1, 2019 the mortgage principal balance was \$151,234.48!!

The Small Business Administration PPP loan was approved on May 1, 2020; and the \$27,300 loan was deposited on May 5. We anticipate that the loan will be forgiven and treated as a grant by the SBA once proper documentation is submitted. Susan Anthony of the Finance Committee is taking the lead on the necessary paperwork to help ensure that the documentation is sufficient and completed on a timely basis.

In November, over \$1,125 was collected for Operation Joy (Christmas for children).

BURN THE WHAT....?

Back in April of 2019, Howard Silverman came up with an idea. Howard serves on the Finance Committee, and at the April finance meeting, he blurted out:

"Hey, we only owe \$151,234 on the mortgage. If 20 people donated an extra \$100 a month, and the rest of us donated what we could towards the principal, we could burn this mortgage in less than four years!"

Well, guess what? At the end of 2020, our mortgage balance is at an amazing **\$93,073!** All Faiths, Howard, and the Finance Committee would like to thank each and every person who has been making extra payments towards the mortgage principal. Many of you send extra payments on a regular basis, and many of you donate here and there, but all of you have made a huge difference, for which we are extremely grateful. When our mortgage balloon comes due in 2024, we just might have to tell the bank... *it was nice doing business with you, but we're done now!*



All Faiths Responds to Food Insecurity in Fort Myers

Food insecurity has become a big issue during the pandemic. Food

banks in our community are concerned about no or dwindling supplies. Nearly 100,000 people experience food insecurity in our county and 28,000 of those are children. Those who typically use food banks are finding that they are even more food insecure during the pandemic and we've learned that over 40% of people accessing food banks right now are first time users. All Faiths will bear witness to this crisis and respond. We will be working with Friendship Missionary Baptist Church on Palm Avenue in Fort Myers to offer donations of non-perishable food items to their food bank. This will not be a one-time offering. All Faiths plans to collect donations on an ongoing basis. For now, simply drop off your donations in the designated box on the porch and Friendship will pick up these donations every Friday. Again, this box will remain for the collection of food items into the future. You may make a donation anytime. Please consider this one of your personal ministries. People are struggling greatly to feed themselves and their families. This crisis deserves our attention and response.

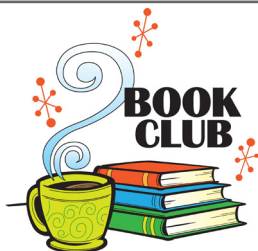

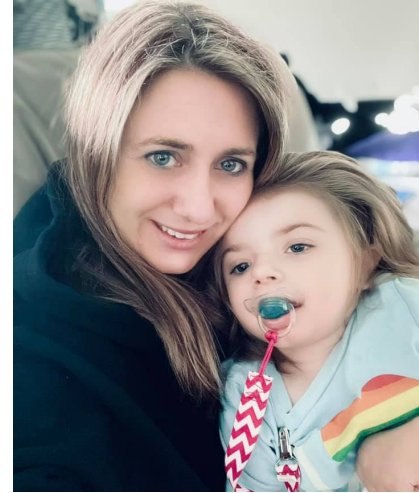

Reflecting upon how they intend to bring light to the darkness in the days to come, responses included: not leaving things unsaid, being the first to reach out, and sharing joy with others through laughter. We approach our exploration of various faiths with an inclusive attitude, understanding that Unitarian Universalism is an expansive ideology that welcomes diversity.

Wednesday evenings have continued to be enthusiastic, interactive, and high-spirited get-togethers. This month, we had the opportunity to welcome and get to know a few of you who chose to spend some time with us during a portion of these meetings. Thank you to Rev. C.J. During one of these gatherings, an extended, thoughtful deliberation ensued regarding how to most responsibly use a \$350 donation sponsored by a congregant to the World Vision charity in the most beneficial manner. I am proud of the remarkable empathy, wisdom, and critical thinking they exhibited as they collaborated on their decision.

We also had our first Parent/Guardian of Youth in RE meeting this month. Although some time was spent reviewing logistics, the main portion focused on participants getting to know each other. Because we can no longer meet over a cup of coffee after the service, the primary purpose of these meetings is for parents/guardians to connect and get to know each other in community.

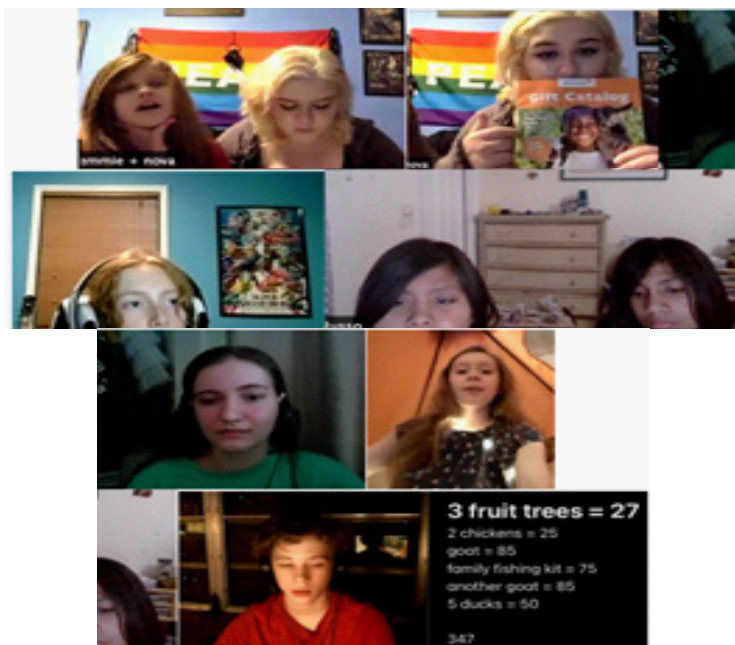
